## LAWS OF 1971

#### CHAPTER 525

AN ACP to amend the general municipal law, in relation to creating and establishing the city of Salamana industrial development agency, and providing for its functions, powers and duties

Became a law June 17, 1971, with the approval of the Governor. Passed on Home Kule request pursuant to Article IX, section 2(b)(2) of the Constitution by a majority vote, three lifths being present

The People of the State of New York, represented in Senate and Assembly, do court as follows:

Section 1. The general municipal law is hereby amended by inserting in title two of article eighteen A, a new section, to be section eight hundred ninety-e, to read as follows:

§ 890 c. City of Salamanca industrial development agency. For the benefit of the city of Salamanca and the inhabitants thereof, an industrial development agency, to be known as the CITY OF SALAMANCA INDUSTRIAL DEVELOPMENT AGENCY, is hereby established for the accomplishment of any or all of the purposes specified in title one of article eighteen-A of this chapter. It shall constitute a body corporate and politic, and be perpetual in duration. It shall have the powers and duties now or hereafter conferred by title one of article eighteen-A of this chapter upon industrial development agencies and provide that the exercise of the powers by such agency with respect to the acquisition of real property whether by purchase, condemnation or otherwise, shall be limited to the corporate limits of the city of Salamanca, and such agency shall take into consideration the local zoning and planning regulations as well as the regional and local comprehensive land use plans. It shall be organized in a manner prescribed by and be subject to the provisions of title one of article eighteen-A of this chapter. Its members shall be appointed by the governing body of the city of Salamanca. The agency, its members, officers and employees and its operations and activities shall in all respects be governed by the provisions of title one of article eighteen-A of this chapter.
